**Subject: Pegasus system - updates & training information**

Dear ASPs,

Ausgrid is continually working with Pegasus Safety & Training Pty Ltd to identify and improve the ASP Authorisation Management System (Pegasus). This notice aims to highlight some of the recent system improvements and development changes that have been implemented based on feedback by ASPs and contractors.

#### Key updates

##### Pegasus Mobile App

To allow for better visibility of worker compliance the Pegasus Mobile App has been developed to allow ASP workers to log in and view their own profile.

This includes:

- Visibility of the Roles (ASP Authorisations) held by the worker
- Status of any competencies held by the worker; and
- Access to the documents used as evidence for competencies held by the worker.

##### Training system development

In December 2020 Ausgrid's Training Delivery group transitioned to the Pegasus system for Ausgrid delivered training bookings. During this transition issues were identified which caused delays and frustration for ASPs. This led to development works to address and fix issues as they were identified, including the following issues:

- Double booking of training courses
- Worker profiles locking out prior to attending training

#### Ausgrid delivered training

##### Booking

Ausgrid delivered training for ASPs is now booked via the Pegasus system. ASP Authorisation roles in the Pegasus system identify the required competencies a worker is required to hold, including relevant training.

To book Ausgrid delivered training, select the appropriate roles for your workers via the Ausgrid Role Management Portal. If the role you have selected requires training to be completed, you will be prompted to book into an available course. [Click here](#) to be taken to a video showing you how to book classroom training in the Roles Portal.

##### Training Waitlist

Where training courses are booked out or unavailable in the scheduled period, they will not show up in the Roles Portal. In these cases, ASPs need to contact Pegasus, either via email or phone, to advise the training they need. Once Pegasus have been advised you will go onto the waitlist for the next available training course.

When new training courses are made available the team at Pegasus will contact ASPs on the waitlist and advise them of the available training dates.

#### Feedback
