Standard Approved Contestable Materials List CEOM7004 Updates

- The Standard Approved Contestable Materials List CEOM7004 is changing from a PDF to an Excel format
- > Issue 57 of the AML will be published in the new Excel format early April 2022

## Background – what happened?

The Standard Approved Contestable Materials List CEOM7004 or 'AML' has been published in a PDF format since inception and serves as the basis of information on approved materials which can be used on the Essential Energy network.

The AML provides quarterly updates to ensure Authorised Service Providers (ASPs) and suppliers have an up-to-date list of approved materials for installation on the Essential Energy network.


To make the user experience easier, the Engineering Team has been working to convert the AML PDF version to an interactive Excel version. This will increase searching capabilities across Asset Groups and Asset Categories for both ASPs and suppliers.

## What do you need to do?

The new format will be published early April. It can be found in the Document Library on Essential Energy's website, www.essentialenergy.com.au

Please familiarise yourself with the new format. There are some minor changes and new additions that assist in navigating the new document.

- CATEGORIES Assets are grouped into Categories to assist with finding items related to one asset. For example, all Streetlight items. Categories can be found on the right-hand buttons or across the bottom tabs as circled in green.
- PREVISIONS PAGE A revisions page has been populated with all updates for the current and previous issues of the last 12 months. This provides a one stop place for all changes and can be quickly accessed without navigating the whole document. The Revisions tab is shown to the right with the blue rectangle.





- > STATUS Beside each item will be an Item Status references, shown below.
  - · Current which means the item or supplier is approved for use
  - <u>Phasing</u> which means the item or supplier has been removed from the AML but is within the twelve-month grace period, after which, it is then removed.
- > SEARCH OPTIONS When searching for an item it can be performed via the standard excel search functionality
- > DESCRIPTIONS Generic descriptions have been used where possible to provide consistency and ease of filtering the document. Some item descriptions have changed, to help enable this filtering.
