Suspension of Ingal Impact Absorbing Columns

- The Ingal range of impact absorbing street light columns have been removed from the AML due to a noncompliance with our technical specification
- > From the publishing of this Construction News, any orders for Impact Absorbing metal streetlight columns must be placed with an alternate supplier listed on the AML.

Background – what happened?

Essential Energy's Design and Construction Standards recommend the use of impact absorbing street light columns within specific zones in urban areas supplied by underground reticulation. To be included on CEOM7004 Standard Contestable (Approved) Material List (AML) items must meet Essential Energy's quality assurance and technical specifications. To be considered Impact Absorbing (frangible), metal streetlight columns must pass impact testing in accordance with Australian & New Zealand Standards 3845.2:2017.

Due to an identified non-compliance the Ingal range of frangible metal streetlight columns have been removed from the AML until further notice.

What happens now?

From 11 May 2022, the Ingal range of impact absorbing street light columns will be removed from the AML, until the non-conformance has been resolved.

Items listed below from Ingal are not to be purchased after 11 May 2022, until further notice. ASP held stock and items currently on order may still be installed. Any purchases after 11 May 2022 **must** be from one of Essential Energy's alternate suppliers listed on the AML.
